



**Town of Green Level Regular Meeting
Green Level Municipal Building
Thursday, September 13, 2012**

The regularly scheduled meeting of the Green Level Town Council was held on Thursday, September 13, 2012 at 7:00 PM in the Municipal Building located at 2510 Green Level Church Road.

GOVERNING BODY MEMBERS PRESENT: Mayor Larry McCollum, Mayor Pro Tem Michael Trollinger, Council Member Reмония Enoch, Council Member Carissa Graves and Council Member Theodore Howard.

GOVERNING BODY STAFF PRESENT: Town Administrator Haywood Cloud and Town Clerk Sandra McCollum.

GREEN LEVEL TOWN ATTORNEY PRESENT: Marissa West (Vernon Law Firm).

Mayor McCollum called the meeting to order, Pro Tem Trollinger gave the invocation.

Town Administrator Updates

The Administrator reminded the Council Members that have not completed the Ethics Course that the deadline will be October, 2012.

The Administrator updated the Council on the event sign that is located on the Town's property next to Dollar General. The cost for the new sign will be \$475.00.

The Administrator stated that the Chamber of Commerce put together a group, to put in place a plan to discuss education in Alamance County with the Alamance-Burlington School Board of Education. The meeting will be held once a month starting Wednesday, September 19, 2012 and is asking for an electoral official to volunteer to be on the board. Council Woman Graves volunteered to serve on the board.

The Administrator informed the Council that Mr. Daniel Gerald is no longer working with the Town's sewer project. Mr. Mike Koser, Withers & Ravenel, will take over at this point. Mr. Koser will be submitting the principle for forgiveness for additional points.

Mr. Koser stated that the Town's water tower project is complete.

Mr. Koser stated that he went back and looked at all of the documents and found out

the Town can submit applications for loans and the principle for forgiveness packages to the State for the Otter Creek pump station and the Basil Holt pump station. Mr. Koser presented a power point to explain the project in detail.

Town Attorney Updates

The Attorney presented the Council with a resolution to review to present to the City of Burlington in agreement that Green Level will be accepted to connect to Burlington for sewer service.

Town Council Comments

Council Member Howard asked if the Town has in place an exempt form, so if a company or person presents money to the Town? The Attorney applied, yes.

Pro Tem Trollinger had no comments.

Council Woman Graves had no comments.

The Mayor gave an update on the Green Level Trojans football teams.

The Mayor asked the Administrator for an update on getting the timber cut on the Town's property. The Administrator replied that the contractor continues to say that he will get stated soon.

The Mayor asked for a motion to adjourn the regular meeting. The motion was made by Council Woman Graves, seconded by Council Woman Enoch. The motion carried unanimously. (5-0)
