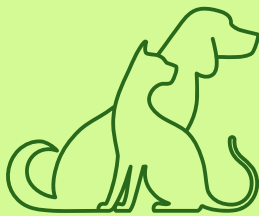
It is easy to find out if you are eligible and to apply for weatherization. For weatherization assistance through Piedmont Triad Region Council (PTRC), residents must live in Alamance, Caswell, Davidson, Forsyth, Guilford, Person, Randolph, or Rockingham and must meet certain income limits. Call the Piedmont Triad Regional Council Office for more information at (336) 904-0338

## Eligibility for Weatherization Assistance

As many as 150,000 households in Alamance, Caswell, Davidson, Forsyth, Guilford, Randolph, Person and Rockingham counties are eligible for weatherization services. If you receive Supplemental Security Income (SSI) you are automatically eligible to receive weatherization services. In other cases, preference is given too;

- Individuals over 60 years of age
- Families with one or more members with a disability
- Families with children

*Anyone can apply for this program, however you must meet income qualifications, starting at \$29,160 annually for a family of 1 up to \$101,120 for a family of 8. For more information contact PTRC at (336) 904-0338*

## Running at Large Prohibited

No person owning or having possession, charge, care, custody or control of any animal shall cause, permit, or allow the animal to stray in any manner to run at large in or upon any public street, sidewalk, or property of another. Dogs shall be exclusively upon owner premises, provided however, that such dog may be off said premises if they are under control of a competent person or restrained by a chain or leash or other means of adequate physical control.

## Dangerous, Vicious Dog Prohibited

If any dog bites or attempts to but any person while such dog is at large, and biter or attempt to bite is unprovoked, then such dog shall be conclusively presumed to be a dangerous dog and a dog of dangerous propensities and tendencies. If any dog attacks or attempts to attack any other dog or animal while such dog is at large or chases or otherwise attempts to catch a person and said attack or attempt to attack, chase, or chase a person is unprovoked, then such dog shall be conclusively presumed to be vicious propensities & tendencies.

*All complaints regarding dog bites & attempts to bite or attach any person, dog, other animal by any dog while such dog is at large or while such dog chases or attempts to catch a person shall be reported to the Alamance Co. Sheriff's Dept.*
