Mayor Pro-Tem Jones made a motion to appoint Sandra McCollum as interim town administrator. Councilmember S. Enoch seconded the motion.

The motion passed (3-2). Mayor Enoch and Councilmember Trollinger voted against the motion.

Mayor Enoch yielded the chair to Mayor Pro-Tem Jones and was excused from the meeting.

Councilmember S. Enoch made a motion to pay Mrs. McCollum \$500 a week until a contract could be drafted and approved. Councilmember Trollinger seconded the motion.

The motion passed unanimously (4-0).

Councilmember McBroom made a motion to authorize Sandra McCollum, as interim town administrator, to approve up to \$5,000 for necessary expenses without direct Council approval. Councilmember S. Enoch seconded the motion.

The motion passed unanimously (4-0).

Councilmember Trollinger made a motion to adjourn the Council until the next regular May 8, 2025, meeting. Councilmember McBroom seconded the motion.

The motion passed unanimously (4-0).

Mayor Pro-Tem Jones adjourned the meeting until May 8, 2025.
